YOUR HOUSE ACCOUNT CAN BE PAID BY CREDIT OR DEBIT CARD, CASH, CHEQUE OR INTERNET BANKING. **ANY CHARGES OUTSTANDING ON THE 20<sup>TH</sup> DAY FROM THE PREVIOUS MONTH'S STATEMENT DATE WILL BE CLOSED TO THIS CREDIT CARD (ALL CREDIT CARD CHARGES ARE SUBJECT TO A 3% INTEREST CHARGE).**
- C. ALL HOUSE ACCOUNTS ARE DUE AND PAYABLE BY THE LAST DAY OF THE MONTH IN WHICH THE STATEMENT IS RECEIVED. INTEREST OF 2% PER MONTH WILL BE CHARGED ON ALL OUTSTANDING ACCOUNTS. TIMES FOR THE WEEKENDS MUST BE AFTER 2PM. THE USE OF ANY OF THE PRACTICE FACILITIES OF THE CLUB AT ANY OTHER TIME IS NOT INCLUDED IN THE SOCIAL MEMBERSHIP**.
- F. ALL SOCIAL MEMBERSHIPS ARE RESPONSIBLE FOR THE SEASONAL CLUBHOUSE CHARGE OF \$850.00 FROM APRIL 1 TO THANKSGIVING MONDAY. THIS CHARGE APPLIES TO FOOD & BEVERAGE ITEMS ONLY. (GST and gratuities are not included)
- G. PLEASE MAKE YOURSELF AWARE OF THE RULES AND REGULATIONS OF THE CLUB AS SET BY THE BOARD OF DIRECTORS. CONDUCT OR BEHAVIOR TO THE EMBARRASSMENT OF THE OTHER MEMBERS OR GLENDALE STAFF WILL NOT BE TOLERATED.
