Description

1. A share shall be allocated to Corporate Membership status. A Shareholder allocated to this share shall become the "Primary Designate Member". This "Primary Designate Member" shall have equivalent to full Shareholder privileges.
2. Up to three (3) maximum additional memberships can be assigned to the Corporate Membership and shall be designated as "Assignees".

Methodology

1. A Corporation must purchase a Treasury Share at the current price set by the Board of Directors. The share price and entrance fee must be paid in full at time of purchase.
2. The Primary Member shall pay for the Annual Dues as set by the Board.
3. The Corporation will be allowed to identify up to three (3) Assignees, who shall each pay Annual Dues as set at by the Board.

The Club maintains a Club Membership roster, and limited data from that roster is currently disclosed for the following purposes:

- 1) To provide Member updates from the Office in regards to upcoming events, Member information and account information.
- 2) Member contact information is posted on the secure Club Roster portion of the Club's website (accessible to Members only).
- 3) Limited Member lists are provided to sporting organizations to which the Glendale Golf & Country Club participates in for the betterment of your Membership. Currently the Alberta Golf Association is the only Association that our Club provides this limited Member list to.

RULES & REGULATIONS

1. ALL MEMBERS ARE SUBJECT TO THE RULES AND REGULATIONS OF THE CLUB AS SET BY THE BOARD OF DIRECTORS OF THE CLUB FROM TIME TO TIME.
2. ONLY THE PRIMARY MEMBER HAS VOTING PRIVILEGES.
3. THE CORPORATION MUST NOTIFY THE CLUB THE NUMBER OF ASSIGNEES THEY WISH TO ASSIGN EACH YEAR, THE NUMBER OF ASSIGNEES CAN BE DECREASED WITHOUT PENALTY.
4. THE ANNUAL DUES MUST BE PAID PRIOR TO GOLF, OR APRIL 1st, WHICHEVER COMES FIRST. GOLFING PRIVILEGES WILL BE DENIED UNTIL ALL ANNUAL FEES ARE PAID AND ALL INDEBTEDNESS IS CLEARED.
5. EACH PLAYER SHALL BE RESPONSIBLE FOR THE ANNUAL CLUBHOUSE MINIMUM CHARGE OF \$850.00.
6. ASSIGNEE PLAYERS ARE RESTRICTED TO BOOKING TEE TIMES FOR MONDAY – FRIDAY OR AFTER 12 NOON SATURDAY, SUNDAY AND HOLIDAYS. SUBJECT TO NORMAL TEE TIME RESTRICTIONS I.E. LADIES MORNING, MEN'S NIGHT, TOURNAMENTS, ETC.
7. ASSIGNEES MUST BE EMPLOYEES OF THE CORPORATION.
8. THE CORPORATE SHARE PROGRAM IS NOT AVAILABLE TO CURRENT SHAREHOLDERS OF THE GLENDALE.
9. THE CORPORATION SHALL BE PERMITTED TO CONVERT THE CORPORATE MEMBERSHIP TO A REGULAR MEMBERSHIP UPON PAYMENT OF THE APPLICABLE TRANSFER FEE.
10. NOTWITHSTANDING ANY OF THE ABOVE THE BOARD RESERVES THE RIGHT TO AMEND OR MODIFY THE CORPORATE MEMBERSHIP PROGRAM FROM YEAR TO YEAR.
11. BREACH OF THE RULES AND REGULATION SHALL RESULT IN FORFEITURE OF

THE PRIVILEGE OF CORPORATE MEMBERSHIP AND THE SHARE WILL BECOME
THE PROPERTY OF THE GLENDALE GOLF AND COUNTRY CLUB.
